Minute RP/19/20/77 refers. Members continued to go through the Budget for 2020 - 2021 line by line. Members used expenditure from the current year's budget to use real time figures.

- Additional monies were put in for an additional member of staff as ratified by Full Council on 25th November, 2019.
- An additional amount of £1000 overtime Budget was placed under Parish Hall.
- The Training Budget was all placed under Administration Budget.
- One budget head was made for Grounds Maintenance and Opening and Closing Play-Spaces.
- Rangers equipment would be purchased some from this year and some next year's budget.
- The Grants Budget was reduced to £5000.
- Monies had been included for the Allotments, Public Conveniences and some towards Play Spaces. Match fund would be required for Play Spaces.

R & P Minutes 2nd December,2019

Cllr Mrs L Vingoe proposed that the figure of £294,976 be recommended to Full Council in January, this was seconded by Cllr M Anderson.

RECOMMENDED: that the figure of £294,976 be taken forward to Full Parish Council as the Precept request. This was a 10.4% increase on the previous year.

To Note: The tax base was not available as yet from Rochford District Council, so could not be worked out. A copy of the proposed budget is attached to these Minutes.
